ABOUT SKYLINE COUNCIL

Skyline Council an auxiliary board of Landmarks Illinois (LI) comprised of emerging leaders. Through service, social engagement and advocacy, Skyline Council members serve as ambassadors for Landmarks Illinois helping to promote its mission to empower people saving places. Since 2011, our networking events have attracted several hundred attendees. Signature events include the Skyline Social, celebrating its 7th anniversary in October, Skyline Historic Pub Crawl, our popular Skyline Trivia Night, and the Skyline Summer Mixer. Skyline Council is also working with the Illinois community of Campton Hills to restore a one-room schoolhouse built in 1852. Skyline Council members are dedicated to engaging emerging, preservation-minded professionals in the work of Landmarks Illinois.

SKYLINE COUNCIL EVENTS

Skyline Social – October 25, 2018 – Marshall’s Landing, Merchandise Mart

Skyline Social is Skyline Council's largest annual fundraising event. In 2017, the Social raised over \$40,000 in support of Landmarks Illinois programs, and attracted nearly 400 guests from the development, real estate and building industries. We will host the 7th Annual Skyline Social at Chicago's iconic and historic Merchandise Mart. Marshall's Landing (pictured below left) opened in 2017 atop the Grand Staircase of the Mart and is "the hang-out spot" for patrons to lounge, socialize, meet, work and eat. In this event space and restaurant overlooking the Chicago river, guests will enjoy hors d'oeuvres, cocktails, music and a tour or two of corporate offices of tenants in the Mart. Past Socials were held at Revel Motor Row (the old Chicago Defender Building), Stoney Island Arts Bank and Chicago Board of Trade.





Two Skyline Trivia Nights Jan. 2019 – Revolution Brewpub

Skyline Council's highly popular Trivia Night is always a sellout. In 2019, the council will host two nights of trivia at Revolution Brewpub in Logan Square. Teams of six compete on topics related to preservation, Chicago history, sports and more. The event is a winter evening of trivia fun, beer, and comradery. Trivia Night is Skyline's 2nd largest fundraiser.



Skyline Historic Neighborhood Pub Crawls - Fall and Spring

Skyline Council plans to select two Chicago neighborhoods to visit in the fall and the spring with an historic bar and pub scene. This casual barhopping event is guided by a local economic or community development organization and features tours of unique (sometimes difficult to get into) historic sites. Past neighborhoods included Uptown, Printer's Row and suburban Geneva.

WHITNEY SCHOOLHOUSE SERVICE PROJECT

Skyline Council is working with Campton Township in Kane County to preserve one of the oldest one-room schoolhouses in Illinois. Constructed in 1852, the Whitney Schoolhouse served as a rural school until the early 20th century. Vacant since the 1980's, the pre-Civil War schoolhouse is threatened and in need of repairs. The Council is engaged in a long-term service project to move and restore it for a new public use. With the help of Skyline Council and co-sponsored by Landmarks Illinois, Campton Township applied for funding from the Grand Victoria Riverboat Fund and was recently awarded \$21,000 in grant funds to aid in its relocation and restoration to nearby Gray Willows Farms. We are currently working on obtaining additional funding for the move of the house and stabilization efforts.
