



## Most Endangered Historic Places in Illinois

### FREQUENTLY ASKED QUESTIONS

#### **What is the Most Endangered Historic Places in Illinois and what does it do?**

The Most Endangered Historic Places in Illinois is an annual list of threatened properties that Landmarks Illinois has released since 1995. The list's purpose is to focus on sites threatened by deterioration, lack of maintenance, insufficient funds or inappropriate development and to bolster local advocacy efforts and build support for each property's eventual preservation. The Most Endangered Historic Places in Illinois list also draws attention to important policy issues that affect these properties and historic properties throughout the state.

#### **What are the benefits of having the place I care about included in the list?**

The Most Endangered list generates a heightened level of public awareness to your site, which can help generate support for its preservation. The program also puts pressure on decision makers to find preservation-based solutions for your site. Landmarks Illinois helps identify opportunities for the preservation of your site and commits to supporting your ongoing advocacy efforts by sharing our resources and expertise. Listing does not guarantee that your place will be saved, but it can significantly boost existing advocacy efforts.

#### **What are examples of places that have been on the list in the past?**

Recent examples of places that have been saved after being included on the Most Endangered list include [Old Cook County Hospital](#) in Chicago, the [Baxter International Headquarters Campus](#) in Deerfield and the [Hotel Belleville](#) in Belleville. #### **How do you choose what places to include?**

The list is selected by Landmarks Illinois staff and confirmed by our Board of Directors. When choosing what sites to include, we look at support and interest

from others in the local community, the urgency of the threat and potential solutions. We also look for alignment with our organizational [guiding principles](#). We are particularly interested in highlighting places that tell the stories of communities that have historically not received equal recognition from the preservation field.

### **Who can nominate a place to be on the list?**

Anyone can nominate a place for the Most Endangered list, including community groups, nonprofit organizations, local governments, historical societies and concerned citizens throughout the state. You do not have to be affiliated with a historic preservation organization or group to nominate a place. However, we do consider the depth of community support when selecting what places to include.

### **What is the timeline for the 2025 Most Endangered list?**

Landmarks Illinois will accept nominations from December 10, 2024, through January 10, 2025. Nominators will be notified in early spring whether their place was selected for the 2025 list. announced. Landmarks Illinois will announce the 2025 Most Endangered Historic Places in Illinois on May 1.

### **What will I need to do if my place is chosen for the list?**

If your place is selected for the list, you'll work with Landmarks Illinois to prepare for announcement day by providing background information, reviewing communications materials, sharing photos and assisting with outreach to local media. While Landmarks Illinois will take the lead on the announcement, the partnership and support of nominators are critical to a successful list.

### **Will submitting multiple nominations increase the chances that my endangered place is selected for the list?**

No, each nominated place receives equal consideration regardless of the number of nominations that are submitted. If you are working with a group or coalition, we prefer that you submit one nomination and indicate in the form that it is collaborative.

### **Can I invite collaborators to view or edit my nomination form?**

### **Does listing a place prevent it from being demolished or inappropriately altered?**

Being included in the Most Endangered list is a purely honorary designation that offers no protection against demolition or alteration. However, the visibility that comes with being included on the list encourages alternative outcomes.

### **Does listing come with funding?**

Being included on the list does not come with any funding attached. However, places that have been on our Most Endangered list do receive special consideration for funding through Landmarks Illinois [grant programs](#).

### **Can I nominate a site for the Most Endangered list if I nominated in the past and wasn't successful?**

Yes, we gladly accept repeat nominations, though re-applying does not guarantee that your place will be selected. Please include in your nomination what has changed for the place since your last nomination.

### **If I submitted a nomination in a previous year, can I just resubmit that form?**

No. Please submit a new form each time you nominate your place. This new form should include any information that has changed since your previous submission(s). Please reach out to us, and we would be happy to send you a PDF of your previous submission.

### **Can a place be included in the Most Endangered list more than once?**

Landmarks Illinois can choose to include a place on more than one Most Endangered list if we believe that repeating a listing will make a meaningful difference to advocacy efforts. We encourage you to reach out to staff to discuss if a repeat listing makes sense for your place before submitting a nomination.
